## What transpired:

President Sherry Messenger gave an overview of the activities in 2022:

Note that our Council liaison is Daniel Fontaine. Treasurer Deb Thomas gave a <u>brief financial</u> & membership report:

- 84 members for 2023 as of tonight
- Chief revenues for 2022: John Cook's sponsorship, membership fees (Total revenues \$2760)
- Major expenses for 2022: (Total expenses \$2166)
  - We bought 2 banners for the garage sale that can be reused
  - Website and hosting fees (every 3 years)
  - Holiday greeting/membership renewal/survey printing

## Guest Speaker - Alison Silgardo, CEO, Senior Services Society

- Supporting seniors that live on their own
- 24% of the homeless are seniors
  - Most never have been homeless before
  - Most are single women, used to be homemakers
  - Homeless prevention plan = mostly when hospitals discharge seniors after extended stays

- The society works with helping seniors get housing, food, and health care
- 22-member team at the society
- 14,000 17,000 calls a year
- Online course to help seniors
- Also assist seniors with taxes and filling out forms
- SHINE = partners all over the province to provide aide
- Outreach = support workers go with seniors to go discuss with landlords, banks, anything they need help with
- Working with new builds to add housing to their affordable housing list

Finally, there were a few concerns expressed from the floor:

- Ensure that the MVH garage sale does not conflict with Queen's Park's sale. [Ours is always the first Saturday of May and theirs is around Mother's Day so they will conflict every 4 or 5 years]
- Concerns about lighting in the neighbourhood. [The MVHRA is in touch with the City regarding this]
- Street signs in New Westminster are too small for aging eyes
- A number of concerns about anticipated traffic congestion once the planned development at 8th Ave and Cumberland is completed. [The MVHRA Executive will look into a general meeting with someone from the City to answer questions about the development]
