The minutes of our last 2 RA meetings be formally adopted as circulated this is in regard to our AGM Jan 23rd and RA Gen Meeting April 10th Moved by Deb Thomas, seconded by Terry Tomcko. Accepted

4 MVH Lighting Infrastructure upgrade with City Engineering presentation

- Kwaku Agyare-Manu, Deputy Director, Eng services
- Hardeep Maghera, Manager of Eng Development Services, Design & Construction

Discussion themes

- Arborist assessment report & overview with respect to Diamond Head Consultant (DHC) report findings
- DHC recommends to shift alignment onto road corridor to avoid root zone in a series of critical areas that are outlined and highlighted in DHC documentation
- If shifting to road corridor, second option is to drill (directional boring) 1 metre below root zone – Highly specialized trade
- CNW will protect trees working alongside arborist (DHC) to incorporate construction means into design layout that ensures health of existing trees



In ground strategy for new infrastructure conduit routing

- Contractor has been appointed based on the overall scope for Phase 1 & 2. (from west to Chilliwack to McBride Blvd) Logistics still being worked out on light posts.
- Lots of utilities in roadways, keeping in mind required clearances and elevations of lines
- Trenching only on City Property, which entails property set back zones behind existing sidewalks
- City will work with residents on a case-by-case basis to ensure minimal impact to Lawn sprinklers, driveways, sidewalks etc. Scope of work will entail making good those disturbed areas
- Current conduits are direct buried (not in metal conduits) & nearing end of life.
 Maintenance issues, as well as possible safety hazards
- Existing inground wiring will be decommissioned, where possible existing will be pulled
 or may just be cut and left, although this could be considered an environmental issue.
 Also, arborists may want it left if encased by tree roots.
- Current scope is for short davit poles light poles, but waiting for final Heritage
 Assessment decision as to final style and preservation efforts of existing light standards

General construction means and methods, including monitoring

- Any damage to residential properties will be made good by the City
- Lampposts original bases are early 1900's, not all in great condition, due to corrosion
- Any restoration of existing lampposts will be determined once final decision on Heritage report.
- City is trying to enforce ANSI light standards, so lighting is consistent in similar areas across the City.
- MVH illumination level is very low compared to City's current standards.
- <u>Heritage Assessment</u> is now on City Website (Heritage) and will be discussed on Oct 1
 <u>Community Heritage Commission | City of New Westminster</u> Will then go to the next
 City Council meeting.
- Schueck Heritage Consulting that prepared the reports Conclusion was "the historic streetlights have significant heritage value. They are important place-making elements of the neighbourhood, helping to define its character. Most important of all, they are highly valued by the residents of the neighbourhood."

- Q1 Conflicts?
- A1 City will work with each property Owner for any conflicts. Case by Case basis. There could even be a possibility that lights could flip to other side of street.
- Q2 What will determine style of light?
- A2 Currently pending outcome from The Heritage Assessment Report of existing light standards and final determination of their heritage status



- Q3 Why can't wiring be put where existing is?
- A3 –Design and final routing for new conduit to be confirm to meet best locations and refined through on-site test pit work

5 <u>MVHRA's overview of Bike Lane concept</u> - based on Active Transportation Network Plan (ATNW) adopted 2022.

- This is a 5 year program. Currently in year 2 and MVH is in 3rd year
- MVH provided high level overview of drawings and text that is contained in the. ATNW 2022 document. Please refer to attached pdf from slides shared during presentation & highlighted content found in the ATNW adopted plan

- **Changes and current status Official Community Plan development** to be adopted end of this year 2025– Update & Discussion w/ Councillor Daniel Fontaine,
 - Refer to attached pdf of MVH slide presentation and particularly the slides on Townhouse program and Infill Program
 - Draft Focus Area Map showing Townhouses on East 8th below Richmond is anticipated. This is the latest pre-zoning strategy the City staff is refining further the public engagement that occurred this spring through a series of City held open houses.
 - A public hearing tentatively to occur early in the new year this pre-zoning Town Housing concept is refined by staff
 - It is important to voice your opinions if you have the opportunity to do so.
 - Once the OCP is approved that is it.
 - Draft Focus Area Map showing Infill Program throughout MVH and New Westminster in general
 - The City is also exploring increasing housing choice through the Infill Housing Program.
 - Infill housing types include includes a variety of housing forms like: duplexes, triplexes, quadplexes, multiplexes, secondary suites, and laneway or carriage



homes. We want to allow owners to have a range of housing options on their lots, allowing up to six units depending on their goals and what will work on their property.

- It is anticipated that a workshop on the program will be held with Council early in the new year, with a public hearing anticipated before the summer of 2026
- Like with the Townhouse, while the City is proposing to update Bylaws now, it is forecasted these new housing forms will gradually be constructed over the next 20 years.
- Once the OCP is approved that is it.
